Soil samples were collected from the assessment soil borings for laboratory analysis of TPH, BTEX, pH, EC, and total metals. The soil samples were in full compliance with COGCC Table 910-1 allowable levels with the exception of total arsenic; however, total arsenic results were less than the United States Geological Survey maximum background level for this soil type.
