SOURCE REMOVAL SUMMARY

Describe how source is to be removed.

Since work began in August, 2018, Wesco has removed and disposed of the soil stockpiled in the former lined soil reclamation site. The liner beneath the staging area was also removed and disposed of at the Rio Blanco County landfill. Wesco has also excavated contaminated soil from beneath the former liner. Approximately 1,900 tons of soil has been removed and disposed of at the Rio Blanco landfill. This includes the material that was stockpiled on top of the liner. Wesco will conduct additional remedial work either this spring or early summer (2019) when weather and snow runoff permits. The COGCC will be notified in advance of any soil sample collection that will be used for approval of excavation closure. The open excavation is currently fenced to prevent wildlife entry. Wesco anticipates that all excavation and backfill work for this project will be completed in 2019, in advance of the March 6th, 2020 compliance date stipulated in the administrative order.

Once analyticals have been received and reviewed, Wesco will continue to move forward with the pit closure.
