HighPoint Operating Corporation requests TA status for the subject well. This well was TA'd with a packer set at 6566' MD. The wellbore is isolated at surface by a closed valve. This well will remain in TA status until third party gas capacity has been increased in the associated pipelines. HighPoint is under a force majeure curtailment situation with DCP Midstream while DCP addresses constraints in the full throughput capacity of their system. Due to these constraints, HighPoint is in constant, ongoing communication with DCP on DCP's plans for addressing the situation from both a short and long-term situation.
