COMMENTS:

Evergreen has tested this well for a limited time and has determined that long-term vacuum operations are mechanically feasible. Evergreen is requesting to impose a partial vacuum at the wellhead per Rule 331. This well has a liquid ring type wellhead compressor. A vacuum will be induced at the wellhead by increasing the speed of this liquid ring pump. Pressures are monitored via SCADA and oxygen sensors will be installed to detect integrity issues. Attached is an exhibit showing the location of all wells on adjacent premises and all offset wells on adjacent lands. Evergreen is the only producer within 1/2 mile of this installation; therefore, requirement for notice of the application to each producer is not applicable.
