COMMENTS:

Gunnison Energy, LLC, respectfully requests a 90-day extension to perform an MIT for this well. The well successfully passed an MIT on June 19, 2014. A 5-year shut-in maintenance MIT was scheduled to be conducted Monday, June 17, 2019, as per the submitted Form 42 Document # 402066001. Onsite preparation for the upcoming MIT occurred this week, and it was determined that the Lone Pine will require a workover rig to conduct an MIT and not the equipment that is currently scheduled for June 17. Gunnison Energy has already contracted a workover rig to conduct other work later this summer and would like to coordinate the Lone Pine MIT with the contracted rig.
