Comments

This well has a bottom-hole location beyond the unit boundary setback. The bottom of the completed interval will be within the unit boundary setback at 150' FNL and 1135' FWL of Section 25. The wellbore beyond the unit boundary setback will be physically isolated and will not be completed.

HighPoint does understand and agrees that there is a slight difference in footage between the section line, and the state line. We agree that our setbacks apply to the state line and not section line.

The distance from completed portion of proposed wellbore to nearest completed portion of offset wellbore permitted or completed within the unit was measured to the Fox Creek 12-63-25-24-2N, this distance was measured in 2D.
