4. TIH with CIBP. Set BP at 4000'. Top with 2 sxs 15.8#/gal CI G cement.
5. TIH with tubing to 1829'. RU cementing company. Mix and pump 40 sxs 14.8#/gal Type III cement down tubing (Pierre coverage from 1800'-1300'). TOC at 1230'.
6. Pick up tubing to 902'. Mix and pump 67 sxs 14.8#/gal Type III cement down tubing. Cement circulate to surface.
7. Cut surface casing 6' below ground level and weld on cap.
