Soil encountered below the produced water vessel will be field screened for volatile organic compound (VOC) concentrations using a photoionization detector (PID). In addition, visual and olfactory observations of the soil will be documented. A confirmation soil sample will be collected below the vessel and submitted for laboratory analysis of benzene, toluene, ethylbenzene, total xylenes (BTEX), naphthalene, total petroleum hydrocarbons (TPH) – gasoline range organics (GRO) by EPA Method 8260B, TPH – diesel range organics (DRO) by EPA Method 8015, pH by EPA Method 9045, and electrical conductivity (EC) by Standard Method (SM) 2510B. If groundwater is encountered below the vessel, a soil sample will be collected from the unsaturated interval and submitted for laboratory analysis of the above-stated compounds.

SOURCE REMOVAL SUMMARY

Describe how source is to be removed.

Soil encountered below the produced water vessel was field screened for volatile organic compound (VOC) concentrations using a photoionization detector (PID) [Table 2]. Five (5) confirmation soil samples (SS01 - SS05) were collected below the vessel and from the sidewalls of the excavation and submitted for laboratory analysis of benzene, toluene, ethylbenzene, total xylenes (BTEX), naphthalene, total petroleum hydrocarbons (TPH) – gasoline range organics (GRO) by EPA Method 8260B, TPH – diesel range organics (DRO) by EPA Method 8015. In addition, the sample collected from below the vessel was analyzed for pH by EPA Method 9045, and electrical conductivity (EC) by Standard Method (SM) 2510B. The sample locations and excavation extent are illustrated on Figure 1. Soil analytical results are summarized in Table 1 and VOC concentrations are summarized in Table 2. The laboratory report is included in Attachment A.
