Set 24" conductor at the base of the wooden conduit depth and drive to refusal. Backfill with Bentonite, pea gravel, and possibly light cement. Air drill main conductor hole to 80'. Set and cement 16" conductor at 80' (as planned) and proceed with well as per original construction plan.

	Operator is required to set 5-1/2" Liner so that gap between the Top of Liner and Bottom of 1st String Casing is between 50 and 100 ft. Gap between the Top of Liner and Bottom of 1st String Casing is typically 50-100 ft. Original Form 2 configuration was Top of Liner @ 8075 ft and Bottom of 1st String @ 9024 ft. That is a gap of 949 ft which is too great. Current proposal is for Top of Liner @ 8980 ft and Bottom of 1st String @ 8990 ft, a gap of 10 ft which is too small.
	Operator may not begin set up and drilling of the well until COGCC receives written documentation that the landowner, Mr. Leffler, approves of the plan to install two conductor strings for protection of his underground drainage system.
