COMMENTS:

A bradenhead gas sample was taken on this well because this well's BH showed a surface casing pressure of 106 psi. This sample shows an H2 gas concentration of 94.23 mol%. An aluminum additive in the cement reacts with water and generates hydrogen gas. Our plan is to open the bradenhead daily to pull off the built-up hydrogen gas to reduce the BH pressure below 50psi. We'll track the starting pressure and how quickly the pressure blows down and then builds up after reclosing the valve. If the pressure doesn't fall below 50 psi after three 30-day blowdowns with 7 day waiting periods in between, we'll follow back up with a COGCC engineer regarding future plans. A follow up Form 4 will be submitted reporting the results of the blowdown.
