 Field Inspector Actions:  
 On 06-27-2019, I Randy Silver area field inspector was assigned a complaint received by COGCC staff in reference to Odor/noise. The complainant John or Heather Shea 1860 Alpine Dr Erie CO stated the issues were occurring outside of her home.  
 On 07-01-2019, I attempted to make contact with the complainant who indicated that on 06-27-19 she experienced roaring noise at 3AM, also banging and clanging noises. Complainant also stated a heavy sulfur and petroleum smells that are quite nauseating. Not able to have windows open and forced to use AC.  
 I performed a complete site inspection of the oil and gas location and associated wells in the area. At time of inspection, I did not smell any unusual odors in or around location. At time of inspection, I spoke with drilling supervisor he stated at time of complaint they were drilling and no unusual activity was taking place. I spoke with him about the clanging noise he stated he would talk to rig crew and address the handling of the pipe on location.
