<p>Comment: Stormwater erosion is occurring in several areas along the access road. Stormwater controls that are in place are largely not adequate or properly installed. Cut banks, silt traps along access are not stabilized and continue to erode. Some culverts are installed above grade resulting in increased erosion at the outlets. Cut-banks along roadside ditches are not stabilized. Velocity checks are not adequately sized or properly installed.</p>						Date: 07/22/2019
<p>Corrective Action: Stormwater controls need to be installed along the access using good engineering practices such as those described in CDOT manuals for erosion and stormwater control. Erosion along the access road needs to be stabilized. This is the second corrective action for erosion along the access road.</p>
