OPERATOR COMMENT AND SUBMITTAL

Comment: Construction began 05/28/2019 (discing area). Surface contamination from another operator (well API 123-08127 was P&A in 2003) was found 06/04/2019 and construction was stopped. The COGCC was notified verbally and a Form19 was submitted (doc# 402066608). A Form27 (doc# 402072831) contains delineation and clean up details. Contamination was noted in 5 prior inspections from 01/12/1996 to 03/08/2000 (doc# 40669, 40668, 40667, 40666, 2440707) and deemed completed 05/15/2000 (doc# 2440708). After removing contamination construction resumed 06/12/2019. Rain on 7 of next 13 days, including 06/21/2019 through 06/23/2019, delayed construction as conditions were too muddy.
