 On 07-15-2019, I Randy Silver area field inspector was assigned a complaint received by COGCC staff in reference to Odor. The complainant Keye Pearson 4020 Wild Horse Dr Broomfield stated the issues were occurring outside of complainants home.  
 On 07-15-2019, I attempted to make contact with the complainant who indicated that on 7-12-19 experienced a chemical odor causing the complainant to close the entire window in complainant's residents.  
 I performed a complete site inspection of the oil and gas location and associated wells in the area. At time of inspection, I did not smell any unusual odors in or around location. At time of inspection operator has changed drilling fluid to NEO flow.
