INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Two partially buried produced water vessels (PWVs) were removed from the Pettinger 1C-18HZ location on May 2, 2019. Groundwater and impacted soil were not encountered in the PWV excavation. The PWVs at this facility have been replaced. Soil samples from the excavation were submitted for laboratory analysis, to determine if a release occurred. The general site layout, soil sample locations, and PWVs excavation dimensions are depicted on the Facility Layout & Sample Locations Map provided as Figure 1.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

On May 2, 2019, following removal of the PWVs, soil samples were collected from the sidewalls of the excavation. A liner was present, therefore no base samples were collected. The liner was intact and in good condition prior to backfilling. The soil samples were field screened for volatile organic compounds using a photoionization detector (PID). Soil samples W01@2', S01@2', E01@2', N01@2', W02@2', S02@2', E02@2', N02@2' were submitted for laboratory analysis of benzene, toluene, ethylbenzene, and total xylenes (BTEX), total petroleum hydrocarbons (TPH), and naphthalene. E01@2' and E02@2' were also analyzed for pH, specific conductance (EC), and sodium adsorption ratio (SAR). Laboratory analytical results for all soil samples indicate that BTEX, TPH, pH, EC, and SAR concentrations and levels were in full compliance with COGCC Table 910-1 allowable levels. The soil sample analytical results are summarized in Table 1, and the laboratory analytical report is attached.
