 Field Inspector Actions:
 On 07-16-2019, I Randy Silver area field inspector was assigned a complaint received by COGCC staff in reference to Dust. The complainant Lizzie Lario Broomfield stated the issues were occurring outside of complainants home.
 On 07-16-2019, I attempted to make contact with the complainant who indicated that on 7-12-19 she observed a large white cloud of dust visible above the sound walls of the Livingston pad.
 I performed a complete site inspection of the oil and gas location and associated wells in the area. At time of inspection, I did not observe any such cloud.
 At time of inspection, I spoke with Manny Parras drilling supervisor he stated at time of complaint they were drilling and unloading cement trucks into the bulk tanks. We spoke about unloading procedures and he stated he would talk to the trucking company.
 Weather conditions: Sunny and location was dry.
