Comment: Approximately 200 Scotch thistles identified within the interim reclamation areas. Additionally soil stockpile that appears to be topsoil is vegetated largely with weedy annual vegetation and needs to be stabilized with desirable perennial vegetation. Revegetation is progressing on well pad fill-slopes, but remains sparse in portions of the cut-slopes.

Corrective Action: Control weeds by August 31, 2019. Seed and stabilize weedy soil stockpile by November 1, 2019. Date **08/31/2019**
