 On 07-17-2019, I Randy Silver area field inspector was assigned a complaint received by COGCC staff in reference to Odor. The complainant Heather Shea 1860 Alpine Drt Erie CO stated the issues were occurring outside complainants home.
 On 07-17-2019, I attempted to make contact with the complainant who indicated that on 7-17-19 she experienced a strong burst of rotten egg/Sulphur odor that lasted approx. 10 min.
 I performed a complete site inspection of the oil and gas location and associated wells in the area. At time of inspection, I did not smell any unusual odors.
 At time of inspection, I spoke with Mike Torres Drilling supervisor he stated at time of complaint they were pulling pipe out of the hole to change down hole equipment and no unusual activity was taking place. Health issues have been referred to CDPHE
 Weather conditions: sunny location was dry
