Extraction hereby certifies to the Director that all Owners within the proposed spacing unit above were notified and 30 days have passed without objection.



 SEC 30 & 29: N2N2




VIC 29W-20-1N WELL TO BE LOCATED 2260' FNL AND 273' FEL, SEC 20, T7N, R67W
