<p>On Thursday 07/18/2019 approximately 10:17 AM, I, Inspector Erica Petrie, conducted a UIC Field Inspection at Expedition Water Solutions, EWS #2, at Location #433830 in Weld, County, Colorado.</p> <p>While there, I observed Water Disposals Injection Operations</p> <p>During this inspection the following possible compliance issues were observed:</p> <p>Weeds at Wellhead, See photo #1, Comply with Rule 603.f, Corrective Action date of 08.19.2019</p> <p>Stormwater issues involving the dry chemical Perlite not being in secondary containment or covered. Comply with Rule 1002.f, Corrective Action date Of 08.19.2019</p> <p>I spoke with Dave Gage, Field Supervisor with EWS. We discussed getting the weeds knocked down around the wellhead, and the Perlite into a Conex or into a secondary containment with tarps on them.</p> <p>A follow up on this site inspection will be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.</p> <p>This is a summary of inspection report.</p>	petrie	07/18/2019
