This is an Interim Reclamation & Stormwater focused Inspection, a Follow Up to Insp Doc#692400970 Dated 5/8/19. Any Corrective Actions from previous Inspections that have not been addressed are still applicable. Not all CAs from previous RI inspection have been resolved.

Location construction was started in 2016- completed in 2018. This site lies within a Sensitive Wildlife Habitat; Greater Sage Grouse and CPW Black Bear Area. Site is less than 1/2 Mile from a Greater Sage Grouse Lek and subject to Wildlife Timing Stipulations. Distance to Freshwater Emergent Wetlands and Fresh Water Pond is 40 Feet. Estimated depth to ground water at Oil and Gas Location 40 Feet.
