INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

A partially buried produced water vessel (PWV) was removed from the Camp 15N-26HZ location on April 30, 2019. Groundwater and impacted soil were not encountered in the PWV excavation. A liner was present beneath the PWV at this site. The PWV at this facility will be rebuilt. Soil samples from the excavation were submitted for laboratory analysis, to determine if a release occurred. The general site layout, soil sample locations, and PWV excavation dimensions are depicted on the Excavation Site Map provided as Figure 1.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

On April 30, 2019, following removal of the PWV, soil samples were collected from the sidewalls of the excavation. Due to the exposed liner beneath the produced water vessel, a base soil sample was not collected. The soil samples were field-screened for volatile organic compounds using a photoionization detector (PID). Soil samples N01@3', E01@3', S01@3', and W01@3' were submitted for laboratory analysis of benzene, toluene, ethylbenzene, and total xylenes (BTEX), total petroleum hydrocarbons (TPH), and naphthalene. Sample N01@3' was also analyzed for pH, specific conductance (EC), and sodium adsorption ratio (SAR). Laboratory analytical results for all soil samples indicate that BTEX, TPH, naphthalene, pH, EC, and SAR concentrations and levels were in full compliance with COGCC Table 910-1 allowable levels. The soil sample analytical results are summarized in Table 1, and the laboratory analytical report is attached.

Laboratory results indicated that all soil samples were in full compliance with COGCC Table 910-1 allowable levels; therefore, no soils were removed. The excavation area was backfilled and contoured to match pre-existing site conditions.

Laboratory results indicated that all soil sample concentrations were in compliance with COGCC allowable levels. Groundwater was not encountered in the PVV excavation. This supplemental Form 27 has been prepared to request a No Further Action (NFA) determination for this site.
