**COGCC Inspection Report Summary**

On Monday, July 15, 2109 at approximately 11:45, I, Inspector Brittani Santistevan, conducted an on-site inspection at FRITZLER 21-22-14 (Great Western), at API #: 05-123-35234 in WELD COUNTY Colorado.

While there, I observed a temporarily abandoned wellhead.

During this inspection the following possible compliance issues were observed:

1. Unused equipment inside of fencing that contains wellhead. COMPLY WITH RULE 603.F. (Corrective Action Date: August 15, 2019) See attached photo #1.

2. Stained soil at wellhead. SECURELY FASTEN ALL VALVES, PIPES, AND FITTINGS TO ENSURE MECHANICAL CONDITION, INSPECT AT REGULAR INTERVALS AND MAINTAIN IN GOOD MECHANICAL CONDITION PER RULE 605.D. (Corrective Action Date: August 15, 2019) See attached photo #2.

A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
