Sundry doc. #400708003 states well is abandoned and has not been drilled. Records show location has been constructed. Large areas of the location have not achieved a uniform desirable perennial vegetative cover per reclamation requirements. Drop-down gate at location entrance in disrepair. Grazing pressure evident and may be hindering reclamation. Advise maintenance.

Location will likely require additional revegetation activities to meet COGCC 1000 series standards.
