In order to continue excavating impacted soil beneath the tank battery associated with Spill/Release Point ID 465241, the tanks and secondary containment infrastructure will need to be removed. In its place, a temporary tank battery will be installed as depicted on Figure 1. Its planned location will be 50 feet from the nearest separator and 120 feet from the nearest gas compressor. This will put the temporary tank in compliance with COGCC Rules 605.a.(6) and 605.a.(7). The tank will also be contained within a sized secondary containment berm.
