Field Inspection Report Doc. #200054044 conducted on 5/7/2004 passed Final Reclamation; however, well was re-plugged by Kerr McGee to comply with COGCC rules and regulations. Since the well location passing Final Reclamation previously it is the responsibility of Kerr McGee to meet Rule 1004 standards.

This location is not in compliance with Rule 1004. The access road, well location, and some other adjacent areas are not reflective of reference crop areas. Refer to the attached inspection photos.

Corrective Action:

Comply with Rule 1004. Collaborate with the landowner to determine mitigating measures that will allow reclamation work to be conducted in such a manner as to not interfere with agricultural activities or crop production. Corrective action date is the date the location was observed out of compliance.
