The surface locations of Extraction's proposed wells have been staked outside of the COGCC Rule 318A.a. Greater Wattenberg Area (GWA) Drilling Window. Rule 318A.a of the COGCC's rules and regulations requires wells to be drilled in a square with sides 400 feet in length, the center of which is the center of any quarter/quarter section or in the center of any quarter section with the four sides being 800 feet in length. Extraction proposes to drill the above referenced wells at a surface location outside a legal drilling window. Extraction is the surface owner and self-waives Rule 318A.a.

Extraction respectfully requests the COGCC to review the enclosed information and approve the requested exception to Rule 318A.a for the Applications for Permits to Drill for the wells on the subject pad(s). This is the best location for the wells because in order to push the facilities further away from Building Units and move them outside of the floodway. The wells must go to the North-West of the window to make room for the facilities.
