## COMMENTS:

Per a COA on COGCC Document ID 698100025, this Form 4 is being submitted to document temporary tank battery operations. This temporary tank battery was set up so remediation activities associated with COGCC Remediation Project 13867/Spill Point ID 465066 could move forward underneath the permanent production tank battery. E&P waste released during this incident impacted soil underneath the production tank battery, thus requiring us to remove it. A sized secondary containment berm was constructed around the temporary tank battery on 6/28/2019. We acknowledge that the temporary tank battery is 35 feet from a production separator. However, all infrastructure that connected natural gas to the glycol burners was removed from service on 6/27/2019 making it impossible for the burner to ignite and signage has been posted advising all operators to not use the burners. Caerus is moving forward with plans to construct a new permanent production tank battery that will be compliant with COGCC Rule 605.a.
