Comment

This is the third corrective action for weeds at this location, as noxious weeds continue to fail to be managed. Approximately 500 musk thistles and 100 Canada thistles observed. Many of the weeds are in flowering condition. Weed management and monitoring described in the 2017 weed control plan is not being conducted.

Corrective Action

Flowering heads need immediate removal, bagging, and proper disposal. Thistle rosettes need to be controlled immediately. A followup inspection will be scheduled within one week of inspection submittal. Corrective action date is back-dated to document non-compliance.
