INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

A partially buried produced water vessel (PWV) was removed from the FT ST VRAIN 3 location on June 25, 2019. Impacted soil and impacted groundwater were not encountered in the PWV excavation. A liner was not present beneath the PWV at this site. The PWV at this facility has been permanently removed. Soil and groundwater samples from the excavation were submitted for laboratory analysis to determine if a release occurred. The general site layout, soil and groundwater sample locations, and PWV excavation dimensions are depicted on the Excavation Site Map provided as Figure 1.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

☒ Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

On June 25, 2019, following removal of the PWV, soil samples were collected from the sidewalls and base of the excavation. The soil samples were field-screened for volatile organic compounds using a photoionization detector (PID). Soil samples B01@7', N01@5', E01@5', S01@5', and W01@5' were submitted for laboratory analysis of benzene, toluene, ethylbenzene, and total xylenes (BTEX), total petroleum hydrocarbons (TPH), and naphthalene. The base soil sample was also analyzed for pH, specific conductance (EC), and sodium adsorption ratio (SAR). Laboratory analytical results for all soil samples indicated that BTEX, TPH, naphthalene, pH, EC, and SAR concentrations and levels were in full compliance with COGCC Table 910-1 allowable levels. The soil sample analytical results are summarized in Table 1, and the laboratory analytical report is attached.

Proposed Groundwater Sampling

Groundwater was encountered in the PWV excavation at approximately 6 feet below ground surface (bgs). One groundwater sample, GW01, was collected from the excavation and submitted for laboratory analysis of BTEX. Laboratory analytical results indicated that the groundwater sample was in full compliance with COGCC Table 910-1 allowable levels for BTEX. The groundwater sampling results are summarized in Table 2 and the laboratory analytical report is attached.

Laboratory results indicated that all soil and groundwater samples were in full compliance with COGCC Table 910-1 allowable levels; therefore, no soils were removed. The excavation area was backfilled and contoured to match pre-existing site conditions.
