This well has a bottom-hole location beyond the unit boundary setback. The bottom of the completed interval will be within the unit boundary setback at 2014' FNL and 2350' FWL of Section 23. The wellbore beyond the unit boundary setback will be physically isolated and will not be completed.

The horizontal portion of every well will be logged with a measured-while-drilling gamma-ray log.
