COMMENTS:

We discovered some residential trash and other things in the process of building the Brighton Lakes pad. Evidently this location was, at one time, someone's yard. We discovered the septic tank, and well control pit, both of which were concrete. The septic tank was empty and dry. Both of these were fully removed and hauled away. We did not find any remnant of a well or leach field and conclude both were removed at some point. We also found a residential trash heap with tires plastic irrigation pipe and other miscellaneous rubbish. We collected and hauled all of that away to the landfill. There was 1 metal drum but, as you can see from the photo, it was crushed long ago and there is no indication of what it contained. GPS coordinates for the locations of the septic, the well pit and the trash heap:
