 Field Inspector Actions:
 On 07-30-2019, I Randy Silver area field inspector was assigned a complaint received by COGCC staff in reference to Noise. The complainant Mackenzie Carignan 3186 Blue Mountain Dr Broomfield CO stated the issues were occurring outside of complainants home.
 On 07-31-2019, I attempted to make contact with the complainant who indicated that on 7-27-19 she stated she could hear the whirring stop and start of what sounds like half siren, half jet engine, starting and stopping repeatedly. I informed her at the time of the complaint the rig crew had TD and was pulling drill pipe out of the hole.
 I performed a complete site inspection of the oil and gas location and associated wells in the area. At time of inspection, I did not observe any unusual sounds.
 At time of inspection, I spoke with Danny Herra drilling supervisor he stated at time of complaint they had TD and were pulling pipe out of the hole. At time of inspection crew was performing normal drilling operations.
 Weather conditions: Clear, location was dry
