

SECOND AMENDMENT OF SURFACE USE AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

WHEREAS, under the date of November 14th, 2003, **W.F. Clough**, ("Surface Owner") and **Williams Production RMT Company** ("Operator"), with Surface Owner and Operator collectively called the ("Parties"), executed a Surface Use Agreement the ("Agreement"); and,

WHEREAS, on September 29, 2006, **W.F. Clough and Williams Production RMT Company** did execute an Amendment of Surface Use Agreement, having a Memorandum of Amended Surface Use Agreement being recorded at Reception #710488 of the official records of Garfield County, State of Colorado; and

WHEREAS, on September 28, 2007, A Deed of Distribution by **Genevieve Clough, as Personal Representative of The Estate of W.F. Clough, aka William F. Clough, aka William Franklin Clough, Deceased**, conveyed surface interest to Genevieve Clough, recorded at Reception #734550 of the official records of Garfield County, State of Colorado; and

WHEREAS, on September 28, 2007, **Genevieve Clough**, conveyed surface interest to **Clough Sheep Company, LLC**, also known as "Surface Owner", recorded at Reception #734551 of the official records of Garfield County, State of Colorado; and

WHEREAS, "Operator" shall now be known as **TEP ROCKY MOUNTAIN LLC** ("TEP"); and,

WHEREAS, TEP requests to add nine (9) new production tanks to the existing tank farm on the RWF 34-12 pad for the purpose of storing produced water from the new wells drilled on the RWF 12-12 and Federal Rulison 8 pad locations; and,

WHEREAS, it is the desire of the Parties to insert the attached Exhibit "D" to the Agreement that depicts the location of the nine (9) new production tanks on the RWF 34-12 pad.

NOW, THEREFORE, in consideration of the premises stated herein and other good and valuable consideration, the receipt and adequacy of which are hereby acknowledged by the Parties hereto, it is agreed:

The Agreement is hereby amended to include the insertion of the attached Exhibit "D" that depicts the location of the nine (9) new production tanks located on the RWF 34-12 pad.

All other terms and conditions of the Agreement remain unaltered and are in full force and effect as of the date hereof; and,

This Second Amendment of Surface Use Agreement shall be binding on any and all successors and assigns of the Parties.


