While there, I observed a producing well site and TNK BTRY                      During this inspection the following possible compliance issues were observed:                      Weeds: Rule 603 f Corrective action date of 8-14-19 See photos 1,2,3,4,5,6,7,13                      Berms: Rule 906 d (1) Corrective action date of 8-31-19 See photos 15,16                      Stained soil: Rule 907 e Corrective action date of 8-31-19 See photo 1,8,10,9,12,14                      Trash: Rule 603 f Corrective action date of 8-14-19 See photo 7                      Mechanical issue: Rule 605 d Corrective action date of 8-31-19 See photos 8,9,11,14                      At time of inspection I observed weeds in and around Well head, Crude and produced water tanks, separator, meter house, meter run and ECD. This is the second year this location has been inspected and cited a corrective action for weeds not being maintained on location. Also it appears there is stained soil around well head, around re-circ pump, in and around HOZ separator and under produced water tank load line. Provide COGCC and inspector with weed maintenance schedule as this location and surrounding locations are not being properly maintained according to COGCC rules. Secondary containment for Produced water tank is inadequate.                      Weather: sunny location is dry.                      A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
