During this inspection compliance issues were observed: Stormwater issues were observed: Sediment moving off location, BMP not in place or needs maintenance on South East side of location. See photos 5 and 6. Erosion is evident along un-stabilized slope on the North side of location. See photos 7 and 8. Unused equipment on location by wellheads. See photos 9 and 10.
