Thank you for using the COGCC Online Tool to file your complaint. Your information has been entered into document number 200447846.

Unfortunately there are 3 in the described area. I called the phone number on the letter (1-844-224-0347) and reached someone in Texas who could not help me. He transferred me to a second person, who also could not help me, and referred me to a phone number (800-220-5824) which was an automated system with no reference to Colorado operations. Google gave me a Denver office number and a Greeley office

number. Denver was not able to direct me at all. Greeley was going to look up the manager for my area and have them give me a call.

This is ridiculous, and in my opinion does not meet the standard for notification.
