	Operator shall notify COGCC EPS personnel no less than 72 hours prior to conducting site investigation.
	The confirmation soil sample was taken at 0-2.5' bgs. However, according to the boring log provided with this remediation a hydrocarbon odor and staining was present at approximately 3-4' bgs accompanied by PID readings elevated relative to the sample depths. In accordance with Rule 910, samples shall be collected from areas most likely to have been impacted. Operator shall collect an additional sample, adjacent to SB01, from the 3-4' depth interval. A subsequent Form 27 shall be submitted within 45 days (September 19, 2019).
