Description of Corrosion Protection:

Prior to 2012: flowlines installed were of various specifications and standards and cathodic protection systems were an incompatible corrosion monitoring method.
After 2012: flowlines were installed with a galvanic protection system utilizing anode beds and with adequate FBE (Fusion Bonded Epoxy) coating, inspected with a Holiday Detector.

Description of Integrity Management Program:

Pre 2018: flowlines are pressure tested annually and given a visual inspection.
Post 2018: flowlines are pressure tested upon installation and annually thereafter.
Sites are visually inspected monthly.
Cathodic protection testing completed on flowlines annually.
Continuous pressure monitoring is utilized on flowlines to indicate large failures, and flowlines are equipped with automatic emergency shutdown.

Construction method used for all public by-ways, road crossings, sensitive wildlife habitats, sensitive areas and natural and manmade watercourses (i.e., bored and cased or bored only)

All lines are installed through open trenching. In public byways, roadways and water courses, the lines are bored in a sleeve for single lines, or in a casing for multiple lines.
Flowline alignments are evaluated for State and Federally sensitive wildlife and plant species.
We conduct an evaluation of State and Federal water regulations and standards and ensure compliance at the time lines are constructed.
Noble's environmental program is designed to protect groundwater resources under the jurisdiction of the Colorado Department of Health and Environment.
Noble evaluates the presence of Cultural Resources in sensitive habitat under the jurisdiction of the State Historic Preservation Officer.
