Request to flare is being made as a result of Anadarko shutting down their Third Creek Gathering System which was the gas sales outlet for the #2 Myer 32-3. It is estimated that approximately 2 MCFD from the well will be flared using a central tank battery combuster. A recent gas sample tested 1/4 PPM hydrogen sulfide in the gas and has been attached.

This flaring request is made necessary by the shutting down of the Anadarko Third Creek Gathering System. The #2 Myers 32-3 is making approximately 2 BOPD and 2 MCFD. Oil revenue dominates the economics of the well. Expansion of a new gathering system being built in the area and the sale of Anadarko assets to Oxy are possible positive developments that gas sales could be reestablished in the future. This request is for an additional year beyond a previous Sundry request from 8/5/2018. COA of previously Sundrys approved in a Stuart Ellsworth 9/28/2018 email will be adhered to.
