Comment: [Outlet protection has been installed at most of the culverts. It is uncertain if enough rock rip/rap was installed or if rock is large enough to handle heavy rain events. Rock check dams were placed into the diversion ditches however, it is uncertain if it is large enough to handle heavy rain events. There was a low spot in the check dams which will cause stormwater to flow around likely eroding into the road. Check dams should be keyed in on the sides with low point in the middle. It is uncertain if all the work has been completed. The stormwater controls will need to be monitored and maintained. See attached photos](#)
