Wellhead located in pasture. Vegetation growth at the time of Form 4 photo collection in the areas presumed to have constituted the working disturbance during drilling matched that of non-disturbed areas both in terms of height and density. No bare patches were observed. Battery facility adjacent to former drilling pad has been stabilized by road base.
