Seventy eight grab soil samples were collected along the sidewalls and base of the excavation and analyzed for TPH-DRO, TPH-GRO, BTEX, and Naphthalene by EPA Methods 8015 and 8260b. SS01 @3' was also analyzed for SAR, EC, and pH by EPA Method 6020/USDA60 (2, 3A), EPA 120.1, and EPA 9045D.

The source was removed from the location through excavation of impacted soil above COGCC Table 910-1 standards. A third party environmental consultant collected laboratory confirmation sampled to determine the final extent.

Eighteen groundwater monitoring wells were installed to determine the extent of dissolved phase impacts. Additional monitoring wells will be required to achieve point of compliance. The ROW permit was approved by Weld County, but the installation was postponed due to a pipeline being installed along the county road.
