Comment: This location is not in compliance with Rule 1004. Reclamation rules require reclamation activities to be conducted within twelve months of plugging on non-cropland. Well was plugged 7/19/2018; therefore, final reclamation activities should have been completed no later than 7/19/2019. Operator has failed to reclaim the tank battery location and a portion of the access road to the well location. COGCC staff did not inspect the entire access road to the well location or the well location. Refer to the attached inspection photo.
