Comments

Nearest wellbore in proposed unit per anti-collision is the Shull Fed 31-32-3HN.

There are no outside-operated wells within 1500'.

This amendment is part of a larger effort to consolidate and use surface locations and existing well permits in the area more efficiently and effectively.

The well name will change from Shull Fed 31-32-3HN to Shull Fed 31-32-4HN.

The well will be moving from Shull Pad 9-59-31-NENW (Loc ID 447902) to Anderson Facility 9-59-31-SESW Pad (Loc ID 447898).

The objective formation and spacing will not change.

The lease/SUA/right-to-construct, TMD, casing/cement, HOP Evaluation, and BMP have been reviewed and updated.

Cultural distances to Building, Building Unit, High Occupancy Building Unit, DOAA, School Facility, School Property Line, and Child Care Center distances are unchanged at >5,280'.

1	Drilling/Completion Operations	Blowout Prevention Equipment ("BOPE"): A double ram annular preventer will be used during drilling.
2	Drilling/Completion Operations	Anti-collision: Operator will perform an anti-collision evaluation of all active (producing, shut in, or temporarily abandoned) offset wellbores that have the potential of being within 150 feet of a proposed well prior to drilling operations for the proposed well. Notice shall be given to all offset operators prior to drilling.
