Comment Corrective action from April 14, 2016 is not addressed. The interim reclamation area remains infested with kochia and there is little desirable vegetation present. Noxious weeds remain on the location uncontrolled. These are ongoing problems that remain unaddressed.

Corrective Action Seeding and any necessary soil treatments need to be completed immediately. Noxious weeds need to be controlled immediately. Corrective action is backdated to document time since location was originally documented as out of compliance. See attached photos.
