Establish vegetation with total perennial non-invasive plant cover of at least eighty (80) percent of pre-disturbance or reference area levels. Use a seed mixture that matches the adjacent pastureland or a seed mixture requested by the landowner. Continue to monitor and manage this site until Final Reclamation has Passed.	CostaR	08/15/2019
Perform reseeding and all reclamation within this fall growing season in order to comply with the 1004 reclamation requirements. The undesirable vegetative debris will need to be removed to allow for proper reseeding. The soils need to be decompacted to a depth of 18inches and tilled to establish a proper seedbed. Once the disturbed areas have been reseeded a certified weed free mulch or equivalent soil stabilization method should be applied to the exposed soils. Weeds should be controlled to facilitate the establishment of desirable vegetation.	CostaR	08/15/2019
It appears the surrounding field is CRP vegetation. It is recommended that the soil at the location be sampled and analyzed to determine if soil issues exist. The soils seem to be compacted at the location which could be the reason that no vegetation grows.	CostaR	08/15/2019
