Comment: The main road has been graded and erosion issue at the location is repaired. The erosion at the location can occur again as rilling is beginning to occur. The culvert at the access road is filling in with sediment, unknown if this was repaired. Erosion needs to be controlled at the source. A sediment trap near the culvert inlet may help settle sediment out before it fills in the culvert. See Attached Photos
