Originally permitted for State 36-8-8-88 SWD #1. This well was drilled, but was renamed State 36-8-88-1R. The well has been P&A. The surface owner has requested to keep the pit as-is for livestock use after closure.

## PROPOSED SAMPLING PLAN

### Proposed Soil Sampling

Nine soil samples will be collected. Two from beneath the impoundment bottom, four along the first 500 feet of the outfall structure, beginning approximately 125 feet from the impoundment, two from the impoundment walls, and one background soil sample collected away from the pit. The two impoundment bottom soil samples, two impoundment wall soil samples, and one outfall soil sample will be analyzed in accordance with Table 910-1 with the exception of barium analysis as discussed with Kris Neidel of COGCC on September 25, 2018. Three outfall soil samples will be analyzed for BTEX, electrical conductivity, sodium adsorption ratio, pH, and TPH for DRO. The background soil sample will be submitted for analysis of arsenic and conductivity and will be used in comparative analysis with the impoundment and outfall soil sampling results.
