It appears all equipment has been removed from the location. There is a two track road that leads to the location from the north and also from the southeast. The location does not look like it has been reclaimed. The location is mostly bare of vegetation with some weedy species. There are signs that cattle heavily use the site. The location may need to be fenced with landowner approval. The location and access road needs to be properly decompacted by cross ripping to 18 inches, seeded, and stabilized.
